Published SECEX Circular No. 39/2022, initiating sunset review on AD duties on acetic acid esters from the US and Mexico

Published SECEX Circular No. 41/2022 dismissing administrative appeal against the suspension due to the public interest of the AD duties on phenol from US and EU
